- 2 days for verification and freezing of the dom
- 20 days for submission of the resp
- 5 days for appointment of the Pane
- 14 days for issuance of the decisior
- Ex-parte proceedings
- Relief:
- Transfer, for second level domains in .UA is available for holders of UA registered mark
- Cancellation

- Confusing similarity with the registered mark
- No rights or legitimate interest
- Use in bad faith

"it appears likely to the Panel that the Respondent has applied for and has registered its trademark in attempt to secure for himself trademark rights in the term "Oppo" and thus to legitimize his ownership of the disputed domain name and circumvent the application of the .UA Policy, while being well aware of the Complainant, its goodwill in its trademark and its established position on the international markets. In this situation, the Panel is not prepared to accept that the Respondent's trademark nor the conduct of the Respondent gives rise to rights or legitimate interests of the Respondent in the disputed domain name under the .UA Policy."
